## 57 Think Green stamps from 53 operators

We are very happy to inform you that a total of 57 stamps out of 62 possible have informed us that they have issued Think Green stamps. Only four operators, Great Britain, Greenland, Russia and Turkey (and no official information from 1 operator) decided not to join this joint issue.
